Alan Yates, Chair of Cheshire & Merseyside Healthcare Partnership joined the C&M Health and Care VCFSE Leaders Group in February. He emphasised the **vital role of the VCSE sector in preventing ill-health** and the importance of **local level interventions.** He maintained that the collaboration of our sector with health and care providers is crucial for a future of making ethical and practical differences to our communities.

Reflecting this, Chris Bentley, a Non-Executive Director at Wirral Community Health and Care NHS Foundation Trust also recently made a presentation exploring the notion of 'place-based approaches to Health Inequalities in the System's Most Vulnerable Neighbourhoods' in Cheshire & Merseyside. He also bolstered the claim that **the gap between services and communities needs to be bridged**. As a suggestion, Chris proposed **linking primary care networks into the already exisitng structures** within the communities. You can find more info and his full presentation **here**.

There is a final opportunity this week for young people aged 16-24 to create content for the **GM History Makers campaign** ahead of March 1st. they want two pieces of digital conent about smoking and tobacco use to be created by a selection of young people, in return for a £400 grant.

Last year, as one of their coronavirus responses the **VS6 Partnerhship** (a partnership of support organisations working with VCFSE sector in Liverpool City Region) hosted a series of assemblies with the VCFSE sector in order to understand some of the impacts of the pandemic on the sector and the effect on certain vulnerable groups:

Children and Young People

Mental Health

Shielded, Vulnerable People and Cares

Inequalities through a BAME lens

The outcomes of the assemblies included priority actions and recommendations for supporting the sector. This year, they have announced their latest report which summaries the findings from the first four assemblies: "Recommendations for
 Building Back Better with the VCFSE Sector". This excellent report will form the foundations for the VS6 manifesto for 2021-24 as well as conversations with key stakeholders, including the LCR Combined Authority.

Furthermore, in partnership with Together Liverpool, the VS6 partnership also organised and hosted the Sustainable and Affordable Food Assembly in order to think strategically about how to develop a plan for the region beyond just emergency provisions. A **full report** has been developed summarising the feedback.
