Who are VSNW

VSNW is the regional voluntary sector network for the North West. Whose purpose is to ensure that the voluntary, community and social enterprise sector, in all its diversity, takes its full part in shaping the future of the North West. VSNW are incorporated as a Company Limited by Guarantee (registration number 3988903) and registered as a Charity (registration number 1081654). VSNW is registered with the Information Commissioners Officer (registration number ZA271106) and you can find out more about our work at www.vsnw.org.uk

When you visit this site we will collect the following data from you

• Information on how you use the site, this includes but is not limited to the resolution of your screen, the browser you use, which pages you are looking and the time you spend on the site.

This information is collected through Google Analytics. This is anonymised and we use IP masking to further protect your privacy.

We will also collect

- Any information you provide to us via email.
- Any information you provide to us when you sign up as a Member of VSNW or one of its programmes such as Cancer Champion
- Any information you provide when you register for a training programme or event
- Your email address and subscription preferences when you sign up to our newsletter.
- How you view our newsletter for example if you open them and which links you click on.

However, VSNW only collects information that is necessary or appropriate to deliver our services. Further details are always provided as part of our website and individuals can visit our organisational wide privacy notice for further information.

Individuals can always refuse to supply personal information, but doing so may prevent them from accessing certain activities online or require them to contact us directly.

Tools We Use

We use four main tools to help us to provide our website and related services to you.



Google Analytics - We use google analytics to analyse how our site is used and to make sure the site meeting the needs of those using it. We don't allow Google Analytics to use or share our analytics data, User-ID is turned off and our data retention rate is set to 14 months. Eventbrite – To support the booking and management of events and training

MailChimp - to collect your details in order to share our newsletters.

Cookies

Like most websites we use cookies to collect anonymous statistics about how people use the site, and to help us keep it relevant for the user. Cookies remember bits of information from your visit to the site.

A cookie is a simple text file that's stored on your computer or mobile device by a website's server. Only that server can retrieve or read the contents of that cookie. Each cookie is unique to your web browser. So if we put a cookie on your computer, it can't be read by any other website.

How we use cookies to collect statistics

To improve our service we collect anonymous web statistics using Google Analytics.

This stores several cookies on users' computers or mobiles devices to tell us how many people have visited each web page, how they got there, and where they navigated to from there. The data collected is completely anonymous and does not store any personal details.

Changing your cookie settings

You can change your computer settings at any time to accept all cookies, to notify you when a cookie is issued, or not to receive cookies. How you do this depends on your web browser.
