### **Updates**

# £21.7 million a year confirmed for Cheshire and Warrington

Cheshire and Warrington will receive £21.7 million a year for the next 30 years as part of devolution plans, with the first £10.85 million expected in 2026–27 ahead of mayoral elections in 2027.

This boost, up from an initial £20 million estimate, takes the total investment to more than £650 million. Funding will be split evenly between capital projects and revenue.

<u>Cheshire and Warrington Infrastructure Partnership</u> is ensuring the VCFSE sector has a strong voice in shaping devolution through its <u>manifesto</u> and the upcoming delivery plan.

Over the coming weeks, local councils will decide whether to move forward with creating a combined authority.

Sefton and St Helens become neighbourhood health pioneers



Sefton and St Helens have been selected as national pioneers in the development of neighbourhood health services.

This initiative is part of the Government's 10-Year Health Plan, aiming to shift care from hospitals to community settings, focusing on prevention and delivering better care closer to home.

The National Neighbourhood Health Implementation Programme (NNHIP) will support 43 areas, including Sefton and St Helens, in developing <a href="neighbourhood">neighbourhood</a> <a href="health">health</a> systems. The initial focus will be on supporting adults with multiple long-term conditions.

Warren Escadale, Chief Executive of VSNW, and member of the NHS C&M Strategic Neighbourhood Health Group and Alliance 42, said: "While the NHS neighbourhood health guidelines published at the start of the year said little about the role of the VCFSE sector, this new programme shows clear recognition of the sector's importance, which is to be applauded. We now need to make the exemplar work with our sector in Sefton, St Helens and elsewhere the everyday standard."

Our C&M VCFSE Health and Care Transformation programme inputted to the strategy's development, reflecting the importance of embedding the sector's voice and role towards improving outcomes for all our communities.

Dave Packwood, who manages our Cheshire and Merseyside VCSE Children and Young People Network that's part of the transformation programme, said: "We welcomed the opportunity to be consulted and involved in the development of the strategy, and we value its recognition of the important role that VCSE organisations can play in tackling unemployment and health inequality."
