# New report highlights VCFSE sector's central role in health and care



Our new progress report from the Cheshire and Merseyside VCFSE Health and Care Transformation Programme shows how VCFSE organisations are already helping deliver key ambitions from the NHS 10 Year Plan, including prevention, neighbourhood health and care closer to home.

The report was launched at the annual inperson C&M VCFSE Health and Care Leaders meeting on Monday 7 July, where attendees also heard from NHS C&M's new chief executive, Cathy Elliott and her thoughts on the importance of the sectors integral role in delivering the NHS 10 year plan.



**Cathy said:** "NHS Cheshire and Merseyside welcomes the 10 Year Health Plan for England and the opportunity to build models of neighbourhood health for the future. Working in partnership with the VCFSE sector will be key to delivering the priorities of the 10 Year Health Plan – especially neighbourhood healthcare."

Examples highlighted in the report include work on early cancer detection, hospital discharge, mental health transformation, support for carers and more inclusive health research, all made possible through partnership working across sectors.

As the programme moves into its next phase, it will continue to focus on strengthening collaboration, supporting prevention-first approaches, and embedding VCFSE organisations in neighbourhood health models.

# Want to know more about what the NHS 10-Year Plan means for the VCFSE sector?

As the NHS sets out a long-term vision for a more preventative, inclusive and community-centred health system, the VCFSE sector is already showing how this can be achieved in practice.

VSNW has published a short explainer highlighting how the sector is already delivering on many of the plan's key priorities - from prevention and neighbourhood working to inclusion and co-production. It also makes the case for stronger partnership working and resourcing, to ensure the sector's contribution is embedded in system planning going forward.

Alongside this, Alliance42, the national network of the 42 Integrated Care System-VCFSE Alliances, has published a coordinated response, calling for:

- Greater VCFSE involvement in ICS strategy and governance
- Recognition of the sector's critical role in tackling health inequalities and shaping neighbourhood health

Together, these contributions reflect a shared message: the VCFSE sector is ready, willing and already delivering — but must be treated as a full and equal partner in building the future of health and care.

#### Feedback needed on devolution manifesto

The Cheshire and Warrington Infrastructure Partnership (CWIP) recently held a webinar to introduce a devolution manifesto for the VCFSE sector.

Cheshire and Warrington has been accepted onto the government's Devolution Priority Programme, with plans to establish a Combined Authority and hold mayoral elections in May 2026.

The draft manifesto outlines 10 key themes to help the sector speak with one voice and influence the devolution process effectively.

#### New policy briefing on tackling child poverty

The Heseltine Institute has published a new policy briefing titled <u>Tackling child and family poverty through a place-based lens: insights from Cheshire and Merseyside</u>.

The briefing uses work from Cheshire and Merseyside as a case study to show how local systems can take meaningful action on complex issues like child and family poverty, when supported by the right data, decision-making power, and a clear shared vision. It highlights the value of collaboration across sectors, including the role of the VCFSE sector, is essential to designing more effective, locally relevant responses to poverty and inequality.
