Updates

Latest on NHS reforms

More details have started to emerge about the <u>structural reforms to the NHS</u> and the halving of internal running costs of integrated care boards (ICBs).

In a <u>letter to local NHS leaders</u> on 1 April, NHS England suggested some internal functional areas – like communications and engagement and assurance and regulation - that ICBs might look at closely as they work up plans for where they'll make their internal savings – with those plans prepared by May and cuts carried out by October.

ICBs are currently not being asked to look at external budgets for things like programmes. Hover our system is still running at a deficit and so may be asked to make further cuts.

The letter and other recent publications from NHS England suggest the role of ICBs will be changing - particularly in the part they play in managing hospitals - and you can read an overview of the wider reforms on the NHS Confederation's website along with an assessment of what this may mean for integrated care systems (ICSs).

Overview of NHS C&M March board

Chair Raj Jain's regular update opened with his reflections on a meeting of his counterparts and chief executives from all 42 ICBs on 13 March, which centred on

the state of the country's finances, the impact of this on the NHS and informing them of reforms to the health service.

Raj's report reminded board members that C&M has the biggest deficit of all systems despite ranking in the middle of all ICBs, when seen as a percentage of its large overall budget.

Place directors combined report gives an overview of what's been happening in your area of C&M, as well as reporting the top five common risks, including delays in neurodevelopment assessments, urgent care flow and safeguarding capacity.

Also on the agenda was a presentation from the C&M Cancer Alliance, a case for change paper from Liverpool adult acute and specialist service providers and an update on public engagement about the city's gynaecology and maternity services.
